Additionally, it addresses key legal, economic, and cultural heritage challenges. The NGO operates primarily in the "Ruczaj" district in Kraków, focusing on integrating local communities and ensuring equal opportunities for individuals regardless of age or socio-economic background. By supplementing formal education with a range of non-formal and informal learning activities, it has made significant contributions to the community.

What Are the Activities and Experience of the Organisation in the Areas Relevant to This Application?

Platforma Integracji Młodzieży is deeply committed to fostering integration, tolerance, and youth development. The organisation has implemented various activities that align with this mission, including youth empowerment workshops, art and creative initiatives, youth exchanges, and community engagement programs.
